### Impersonating Your Financial Institution

Fraudsters will impersonate a bank or credit union that you have an account with to try and trick you into giving away your money or personal information. They pretend to be someone from the "security or fraud department" and contact you via text. The message can be something like "your account has been locked out due to suspicious activity" and will demand immediate action to restore it. In this case, they'll ask you to go to a website and supply your password to verify your identity and unlock your account. However, the website is fake, created by the fraudster to steal your password and gain online access to your account.

Whenever you get a text supposedly from your financial institution, you should do the following:

- Never click or tap any links in the text. Instead, go to the official website and check if you can login to your account from there.
- Verify beyond just caller ID.
  Fraudsters have ways to make the caller ID look like it's from your financial institution. Contact your bank or credit union through an official phone number or channel and verify the request.
- *Beware of urgency.* Fraudsters want to put the pressure on you so that you act without checking if it's legitimate. If they demand you take immediate action, it's likely fraudulent.
